1.- PURPOSE

To establish the necessary and minimum general requirements to be met by the civil liability insurance and "all risk construction and assembly" insurance policies to be taken out by the Contractors providing their services in the sphere of EDP ESPAÑA, S.A.U.

The final recipients of this process are the Contractors that provide services in the sphere of EDP ESPAÑA, S.A.U and the Departments of the different EDP ESPAÑA, S.A.U. companies that need to contract their services.

2.- DEFINITIONS

3.- OPERATING RATIONALE

We differentiate between:

- 3.1. CIVIL LIABILITY INSURANCE
- 3.2. ALL RISK CONSTRUCTION AND ASSEMBLY
- 3.3. TABLES OF AREAS OF ACTIVITY, DAMAGE ASSESSMENT AND COMPENSATION LIMITS OF THE POLICIES.

3.1. CIVIL LIABILITY INSURANCE

The Contractor, at its sole cost and expense, shall take out and keep in force throughout the term of the contract, a civil liability insurance policy with a reputable and creditworthy insurance company. The policy shall cover any possible material damage and personal injury, along with their consequential damages, arising from the activities contracted during the implementation of the works.

This policy shall not only cover the Civil Liability regarding possible damage to property and third-parties, external to EDP ESPAÑA, S.A.U., but also the contractual liability regarding individuals or property of the individuals and of EDP ESPAÑA, S.A.U. companies, which may be damaged by the actions of the Contractors or by the Subcontractors answering to the former.

The contracting company of the EDP España Group shall appear as the insured on the policy, when so required by EDP given the needs of the work to be carried out by the Contractor.

Should, the Contractor need to subcontract any part of the service contracted to the Contractor with the prior written approval of any of the EDP ESPAÑA, S.A.U companies, the policy has to cover any damage caused by the companies subcontracted by the Contractor.

On formalising the contract, the Contractor shall send the insurance certificate and a copy of proof of payment of the premium of the Civil Liability Insurance or the All Risk Construction and Assembly Insurance as applicable, to the following:

Notwithstanding the cover or limits established by current legislation, the minimum cover per loss is indicated in the attached table in accordance with the type of service provided.

The cover required of the policy shall be:

- General
- Employers
- Cross
- Post-works
- Bonds and defence
- Product (when the work consists of delivering a final product)
- Property damage and personal injury, along with the consequential damages.

The cover of the Employers Liability Insurance may be sub-limited per victim to an acceptable minimum of EUR 300,000.

3.2.- ALL RISK CONSTRUCTION AND ASSEMBLY INSURANCE

This insurance needs to be contracted when construction and/or assembly is to take place.

If the policies that the Contractor has taken out do not meet the indicated needs, the Contractor shall be required to take out specific policies.

The contracting company of the EDP España Group shall appeared as the insured on those policies, when so required by EDP given the needs of the work to be carried out by the Contractor.

The cover required of the policy shall be:

- All risk construction and assembly
- Cost of rubble removal
- Machinery and equipment
- Natural hazards
- Strike, riot and civil unrest
- Terrorism
- Extended maintenance
- Pre-existing
- Accidental pollution

The sums insured shall adapt to the volume of the work envisaged in the contract.
